Decision

On Service fees of the Bank of the Lao PDR

- Pursuant to Article 11 of the Regulation on the Management of Foreign Currencies Businesses of the Bank of the Lao PDR No.03/BOL, dated 28 December 2000;
- Pursuant to Actual Expenditure of the Bank of the Lao PDR for Supplying Various Services.

The Governor of the Bank of the Lao PDR hereby issued a Decision:

Article 1: Collection of Service Fees of the bank of the Lao PDR is as following:

I. The service fees for management of accounts

1. Issuance of certificate of deposits

- 2. Account statement printing fees
 - 1-15 pieces of paper
 - 16-30 pieces of paper
 - 31-50 pieces of paper
 - _ More than 51 pieces of paper

II. Service fees for transfer of money

1. Overseas transfers

- SWIFT fees
- Transfer fees

Remarks: Outbound money transfer fees minimum of 50,000 Kip and maximum of 5,000,000 Kip and there might be additional fees collected by a branch of the overseas bank.

- 2. Inbound money transfer from overseas 0.05% of value/time Remarks: Inbound money transfer fees minimum of 50,000 Kip and maximum of 3,000,000 Kip and there might be additional fees collected by a branch of the overseas bank.
- 3. Money transfer to other provinces by Facsimile, Fax 15,000 Kip/time
- 4. Money transfer from an international organization to client account in Lao 30.000 Kip/time PDR.
